

Great Corporate earnings surprises take Wall Street for a ride up.

The U.S. and European stock markets began the week with solid gains as investors focused on the corporate earnings parade that has seen more corporations beat estimates than those missing them.

The four indexes closed higher today as the market attempts to add more gains to those achieved last week.

Local investors are anxiously awaiting the 3Q22 earnings results from First Bancorp (FBP), due 10/25; Popular, Inc., due 10/26; and Evertec (EVTC), expected on 11/2.

Meanwhile, tech-savvy investors await the results from Alphabet (GOOG) and Microsoft (MSFT) on 10/25, while Apple (AAPL) and Amazon (AMZN) are due on 10/26.
